**Proposed Suspension Is Reasonably Estimated to Enable the Pension Plan to Avoid Insolvency**

This application filed on behalf of the Pension Plan includes an actuarial certification of plan solvency under ERISA § 305(e)(9)(c)(i) and IRC Section 432(e)(9)(C)(i) as of the effective date of the proposed benefit suspension, which is May 1, 2017.

Exhibit IV of Checklist Item #7 provides an illustration based on the deterministic basis showing that the proposed suspension is reasonably estimated to avoid insolvency throughout the extended period. This illustration provides the market value and solvency ratio for the period beginning on May 1, 2015 and ending on April 30, 2050. As of April 30, 2050, the funding percentage for the Pension Plan is projected to be less than 100%.

The stochastic projections are not required for the Pension Plan. See Revenue Procedure 2016-27, Section 4.02(2).

Exhibit VII of Checklist Item #7 describes the actuarial assumptions and methodology used in the reports filed with this application, as required under Revenue Procedure 2016-27, Section 4.02(3).
